### **BYLAW NO. 01-2024**

# A BYLAW TO ALLOW FOR THE PUBLIC POSSESSION AND CONSUMPTION OF ALCOHOL IN DESIGNATED PUBLIC SPACES WITHIN THE MUNICIPAL BOUNDARIES OF THE TOWN OF LASHBURN

The Council of the Town of Lashburn in the Province of Saskatchewan enacts as follows:

- 1. That as per the authority granted by the *Municipalities Act*, and in accordance with the Province of Saskatchewan's authorization to allow municipalities and park authorities in the province to designate outdoor public places such as parks for consumption of beverage alcohol, the Town of Lashburn will hereafter allow for the consumption of beverage alcohol within the hours of 10:00 a.m. to 1:30 a.m. at the designated area of the Lashburn Sportsgrounds, and other areas that may be designated at council discretion.
- 2. The designated area of the Lashburn Sportsgrounds is within LSD 1-08-48-25 W3 Ext 48 (attached as appendix A) and is understood to be the area in and around the ball diamonds at adjacent camping and public spaces within that area unless otherwise stated.
- 3. This permission does not extend to the public consumption of beverage alcohol to other public areas or parks within the Town of Lashburn, which will continue to require liquor and/or special occasion permits.
- 4. This bylaw permits the practice of camping or tenting on Town land in concert to an event at the sportsgrounds for a period not to exceed three days. Upon the completion of a third day of camping/tenting/recreational stay the occupants are expected to leave or will be considered a nuisance under applicable Town bylaws (The Nuisance Abatement Bylaw No. 2-2006).
- 5. All laws of Saskatchewan in regards to alcohol consumption will continue to be followed within all areas of the Town of Lashburn including the designated area at all times. These laws include the forbiddance of alcohol consumption by minors, the operation of motorized vehicles while intoxicated, public intoxication, and the causing of any resident any nuisance within this town.

6. As per section 106(1) of the *Municipalities Act*, the coming into force of this bylaw is upon having received third reading.


